### **MANAGEMENT ASPECTS OF RUSSIAN NORTHERN TERRITORIES DEVELOPMENT (with the international participants)**

Proceedings of the conference oriented on the analysis of the actual problems of the Russian Northern and Arctic territories development and determination of the modern and effective mechanisms of their management. Specialists and experts of federal and international level will take part in the Conference.

Conference Organizing Committee is headed by the Chairman of the Government of the Republic of Komi V.A. Tukmakov.

During the Conference, we are planning to organize the session of the working group of the Arctic Committee about the dioxins and furan, under the chairmanship of Åke Mikaelsson from the Swedish Environmental Protection Agency.

The Conference includes plenary session with the core reports from the representatives of the Government of the Republic, Russian and foreign experts; several panel discussions about the development of the modern settlement infrastructure in the High North and Arctic territories, natural environment protection problems, formation of scientific, professional and other conditions of the modern Russian North development.

The Conference will be organized in the following areas:

1. The resource use, natural environment protection, problems of management.
2. Social and cultural processes on the territory of the Republic of Komi: History and Present.
3. Science and management: actual problems of mechanisms of management of development of the northern territories formation.
4. International integration in the Arctic for sustainable development (Arctic Council, Barents Euro-Arctic Region and other projects and organizations).
5. Human capital: social partnership of business and/or governance challenges of the civil society.
6. Social and macroeconomic conditions of the High North and Arctic territories development.
7. Legislation improvement as an important factor of the region development.

8. The contribution of education and science in problem solution of the social and economic innovative priorities of Russia.
9. Public-private partnership in the High North and Arctic development: political and legal features.

Opening session will be held in the State Council of the Republic of Komi. At the end of the Conference, the collection of articles will be published and placed in the bibliographic database of the scientific publications of the Russian scientists ELIBRARY.ru (Russian Science Citation Index). The program of the Conference will be sent to all the participants beforehand.

**To participate in the Conference you must register till the 26.09.2015.** *The Organizing Committee has the right to refuse the publication of the articles which are not relevant to the perspective of the Conference and also formatted with the violation of the rules above*

  - Printed variant of the Article (bring it to the Organizing Committee or send it to: 11, Kommunisticheskaya street, Office 305, Syktyvkar, Republic of Komi, 167982)

#### **The requirements for article formatting:**

1. Article length shall be 6 pages (A4) maximum; fields: left field – 3 cm, right, top and bottom – 2 cm; printing type – Times New Roman; type size – 14 points; line spacing – one-and-a half.
2. The article shall be provided in 2 versions:
  - 1) In the electronic form in Microsoft Word; the name of the file is determined as the first author's surname (e.g.: surname.doc). This article is provided together with the Application.
  - 2) In the printed form, together with the Application of License Agreement (Annex 2). All the pages of the article must be enumerate and fasten. This variant shall be signed by all the authors and can be presented by a participant at the registration for the Conference.
3. Drawings and photos should be black-and-white and should be duplicated in the form of the independent files (each in separate file). The picture resolution should be not less than 300 pixels/inch. Pictures and tables shall be enumerated and have titles (e.g.: the results of research are shown in the table №2). The name of the picture and the comments shall be presented under it,

the title of the table – above it. All the Latin scripts in the text shall be in italics: *sin, cos, tg, ctg, exp, In, const, min, max, Pr, Re*. All the Greek scripts and special symbols shall be printed in Roman Type. Math expressions and formulas shall be printed in the new lines and shall be separated by the empty lines before and after the formulae.

4. The list of the references shall be made as a separate section at the end of the article. The sources shall be listed in order of their citation in the article. Reference to the source in the text shall be printed as a number in square brackets (E.g.: [1])
5. The information about the author (authors) of the article shall be attached. Required information: family name, name, place of employment, position with the indication of the department, chair, laboratory, etc., a scientific degree, title, phone number, e-mail.
6. The UDC number shall be printed in the high left corner of the first page.

**2. RIGHTS AND OBLIGATIONS OG THE PARTIES**

2.1. Under this Agreement the Author freely grants the following rights:

2.1.1. The right to reproduce and distribute the Article the following way: making copies of the work, recording in the computer, publishing in the periodic or proceeding editions of the materials of the All-Russian Scientific Conference “Management Aspects of Russian Northern Territories Development”
