



A new edited book on Social Aspects of Aging in Indigenous Communities

AND DATE FOR SUBMISSION OF COMPLETED CHAPTERS: AUGUST 30, 2020

Our proposed edited book will include chapters that report on; 1) research studies on the social aspects of aging among Indigenous populations around the world, including cultural, social, and/or economic contributions of older Indigenous adults in their communities, 2) perceptions of aging and well-being among Indigenous populations, 3) theories about Indigenous aging, and 4) policy and intervention practices (i.e., programs and services) related to older Indigenous adults.

The book will include the following sections:

1. Economic factors in the wellbeing of older adults in Indigenous communities around the world
 - a. Economic well-being, poverty prevalence, and barriers and/or challenges related to these economic factors among older Indigenous adults
 - b. Roles and economic contributions of older Indigenous adults in the community
 - i. Unrecognized contributions in family and community (grandparents raising grandchildren, sandwich generation)
 - ii. Volunteerism/productive aging
 - iii. Retirement
 - iv. Small business or informal economic activities
2. Effects of environmental factors on older Indigenous adults' social, economic and cultural life
 - a. Changes in access and use of ancestral lands (migratory patterns, access to subsistence foods)
 - b. Climate change and natural disasters
 - c. Water and air pollution
3. Informal support networks (family & community) and social isolation among older Indigenous people
 - a. Family units and migration (shifting family dynamics, changing support networks)
 - b. Changes to communities and attachments to community
 - c. Connections to land and place
4. Elders in Indigenous families and communities
 - a. Roles and contributions of Elders role in Indigenous communities and families
 - b. Changing meanings and purposes of Elders with the shifting family and

- community dynamics
- c. Impacts on quality of life and well-being in Indigenous families and communities related to these changes
5. Effects of spirituality and religion on older Indigenous adults
 - a. Historical roots, history and colonization, discrimination and/or oppression
 - b. Shifts in cultural and/or traditional values
 - c. Impact of religion and spirituality on well-being
 6. Current and best practices related to interventions and their outcomes in relation to quality of life of older Indigenous adults.
 - a. Challenges researchers have faced when culturally adapting interventions for older adults in Indigenous communities.
 - b. Reported benefits to older Indigenous adults of participating in intervention development.
 - c. Lessons learned and best practices of intervention development – recommendations for researchers planning to partner with Indigenous communities to develop older adult programs/interventions.
 7. Approaches and challenges of research when working with Indigenous older adults and culturally appropriate research methods and methodologies
 - a. Indigenous knowledge systems
 - b. Research ethics – history, challenges, lessons learned
 - c. Cultural safety
 - d. Community, or tribal based participatory research

- Tribal or local ethical approvals for chapter content (if data is presented)

Abstracts should be no more than 500 words in length. The chapter must not have been previously published elsewhere. We require chapters to be no more than 30 pages in length (double-spaced 12 pt. in Times Roman font) and in Word format.
